### **1. Introduction**

1.1 Our website uses cookies.

1.2 By using our website and agreeing to this policy, you consent to our use of cookies in accordance with the terms of this policy.

### **2. Credit**

### **3. About cookies**

3.1 A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server.

3.2 Cookies may be either "persistent" cookies or "session" cookies: a persistent cookie will be stored by a web browser and will remain valid until its set expiry date, unless deleted by the user before the expiry date; a session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.

3.3 Cookies do not typically contain any information that personally identifies a user, but personal information that we store about you may be linked to the information stored in and obtained from cookies.

3.4 Cookies can be used by web servers to identify and track users as they navigate different pages on a website and identify users returning to a website.

3.5 If you take the opportunity to 'share' McComb Partnership Ltd website content with friends through social networks – such as Facebook and Twitter - you may be sent cookies from these websites. We don't control the setting of these cookies, so we suggest you check the third-party websites for more information about their cookies and how to manage them.

## 4. Our cookies

4.1 We use cookies to make our website work.

4.2 The cookies that we use on our website, and the purposes for which they are used, are set out in section 11.

(a) Remembering your search settings. There is no way to prevent these cookies being set other than to not use our site.

## 5. Analytics cookies

5.1 We use Google Analytics to analyse the use of our website.

5.2 Our analytics service provider generates statistical and other information about website use by means of cookies.

5.4 The information generated relating to our website is used to create reports about the use of our website.

## 6. Third-party cookies

6.1 Our website also uses third party cookies.

6.2 Details of the third-party cookies used by our website are set out below:

(a) So you can easily "Like" or share our content on the likes of Facebook and Twitter we have included sharing buttons on our site. Cookies are set by: Twitter ([privacy policy](#)) & Facebook ([privacy policy](#)). The privacy implications on this will vary from social network to social network and will be dependent on the privacy settings you have chosen on these networks.

## 7. Blocking cookies

7.1 Most browsers allow you to refuse to accept cookies; for example:

(a) in Edge (version 93.x) you can block cookies by clicking "Settings" option, then choose "Cookies and site permissions", where you can manage the cookie options.

(b) in Firefox (version 94) you can block cookies by clicking "Application Menu", "Privacy & Security", selecting "Manage Data" under Cookies and site Data.

(c) in Chrome (version 96), you can block all cookies by accessing the "Customise and control" menu, and clicking "Settings", "choose "Privacy and Security" and "Cookies and other site data".

7.2 Blocking all cookies will have a negative impact upon the usability of many websites.

7.3 If you block cookies, you will not be able to use all the features on our website.

## 8. Deleting cookies

8.1 You can delete cookies already stored on your computer; for example:

(a) in Edge (version 95), you must manually delete cookie files by going to the following page <edge://settings/privacy>, and choosing clear browsing data, and selecting cookies option.

(b) in Firefox (version 94), you must manually delete cookie files by going to the following page <about:preferences#privacy>, and choosing clear data (Under cookies and site data), and selecting cookies option.

(c) in Chrome (version 96), you must manually delete cookie files by going to the following page <chrome://settings/privacy>, and choosing clear browsing data, and selecting cookies option.

_ga	Analytics	The _ga cookie, installed by Google Analytics, calculates visitor, session and campaign data and also keeps track of site usage for the site's analytic report. The cookie stores information anonymously and assigns a randomly generated number to recognise unique visitors.	2 Years
_gid	Analytics	Installed by Google Analytics, _gid cookie stores information on how visitors use a website, while also creating an analytics report of the website's performance. Some of the data that are collected include the number of visitors, their source, and the pages they visit anonymously.	1 Day
